

2011 Walled Lake Braves Parent Contract

RULES FOR OUR PARTICIPANT

As a parent/guardian of a Walled Lake Braves Participant, I understand that:

1. All **practices are mandatory**. This includes practice during inclement weather.
2. If unable to attend a practice, your coach must be contacted.
3. One (1) unexcused absence from a practice, will not allow your child the opportunity to start a game. Two (2) unexcused absences will result in reduced playing time. Unexcused absences are defined as but not limited to, not showing up to practice without calling your coach.
4. Inappropriate language, hitting, teasing or name calling will not be tolerated.
5. Participants must arrive a minimum of one (1) hour prior to all games, unless otherwise noted by a coach.
6. Proper game day attire is required.
7. Game uniforms are not to be worn to practice.
8. Coaches have the authority to remove a player from a game, prior or during, due to misconduct or unexcused absences.
9. Players will be asked to leave the organization if there are repeated absences, behavioral problems, disrespect or if they are continuously dropped off or picked up late.

RULES FOR OUR PARENTS/GUARDIANS

I understand that the Walled Lake Braves is a non-profit organization, run solely by volunteers. As a parent I will:

1. **Volunteer a minimum of two (2) times during the season** on game days, either on the field or at concessions.
2. Provide a volunteer for that duty if I am unable to fulfill my responsibility.
3. Report for my assigned duty on time. NO children are allowed in the concessions area, press box or on the field.
4. Help my child **fundraise at least \$100** for the Walled Lake Braves. \$50 of that amount must be in sold raffle tickets, the balance is of your choosing. Anyone who has NOT met the fundraising requirement will not be allowed to return the following season.
5. Understand that **\$50 of my registration fee is non-refundable** --- no monies will be refunded after April 1, 2011.
6. Supply information necessary for my child to play (i.e. birth certificate, physical) which must be turned in prior to or at equipment hand out.
7. Pick up and drop off my player/cheerleader promptly for practices and games.
8. Return all equipment/uniforms promptly when scheduled, or my \$50 equipment deposit will be forfeited. All equipment must be returned in the same condition in which it was received.
9. Understand that in order for my child **to register as a returning player next season he/she must end the season in good standing**. (Good standing is defined as having participated through the completion of the season, having paid all fees and met all fundraising/volunteer requirements, and returned all Braves equipment by the due date.)
10. Address any coaching issues, negative as well as positive, to the attention of the Athletic Director.
11. Conduct myself in a positive manner, at the practice field and/or in the stands. There will be no use of profanity or name calling.
12. Be a positive role model for my player and his/her peers.
13. Note that no alcoholic beverages, tobacco or drugs are permitted on school grounds.
